**INFORMATION ON THE TRANSFORMATION OF
sole proprietorship conducted under the business name "RAFCOM Rafał Ziółkowski"

Dear Sirs,

We would like to kindly inform that as of **April 3, 2023** (the date of transformation), Rafał Ziółkowski's sole proprietorship operating under the business name **RAFCOM Rafał Ziółkowski**, at the address: 05-816 Reguły, ul. Stanisława Bodycha 97, NIP: 9512057404 (transformed entrepreneur) **was transformed into RAFCOM spółka z ograniczoną odpowiedzialnością with its registered office in Reguły** (transformed company), pursuant to the Article 551 § 5 of the Polish Commercial Companies Code. As proof of transformation, I am enclosing information corresponding to the extract from the Register of Entrepreneurs of the National Court Register current as of April 4, 2023.

As a result of the transformation, the company **RAFCOM spółka z ograniczoną odpowiedzialnością (formerly "RAFCOM Rafał Ziółkowski")** was established with its registered office in Reguły, 97 Stanisława Bodycha Street, 05-816 Reguły, KRS: 0001029234, NIP: 5342663114. The company's name, legal form and tax identification number (NIP) have been changed. Other information such as registered office, address and bank account numbers remain unchanged.

In addition, we would like to inform that, pursuant to the Article 584² § 1 of the Polish Commercial Companies Code, the company **RAFCOM spółka z ograniczoną odpowiedzialnością with its registered office in Reguły** (transformed company) is a legal successor of transformed entrepreneur. The transformed company is entitled to all of the rights and obligations incurred by the transformed entrepreneur before transformation, especially rights and obligations under concluded contracts, as well as permits, concessions and reliefs that were granted to the entrepreneur before its transformation, unless the law or the decision on granting the permit, concession or relief provides otherwise. Consequently, all concluded obligations and contracts will, by virtue of law, continue under the existing terms and conditions.




